A Note from Marilyn

What a winter we have had up to now. As I look at a snow-covered map of the United States, I am ready for winter to be over. And I am looking forward to a fun Colorado reunion, only about 5 months away. Yes, that is right. Our next reunion will be July 29-31, 2011, at Golden Bell Ranch, just north of Divide, Colorado. We have started making plans for this year and believe that we will have a lot of fun activities for all ages. We also want to have lots of time for us to get reacquainted with family members we have not seen for a while, and to meet new family who may get to join us.

Reunion will start with registration at 4:00 p.m. on July 29th, followed by a meal together and an evening of getting acquainted. We will have Saturday activities planned, with family photos taken after lunch at noon. Optional activities available at all times include disc golf, volleyball, hiking, miniature golf, and swimming.

In the main lodge room we have 24 hour access to snacks, board games, singing around the piano, and digging through family memorabilia. And please bring items for an auction, which is our family fundraiser. We will also plan other activities which will be announced later. We will have an evening "Talent Show" so bring your skits, songs, or instruments and plan to participate.

Cost for the weekend, which includes two nights lodging and 6 meals, is as follows:

Adults: \$150.00
Ages 12 - 17: \$100.00
Children: 6-11: \$50.00
Children: 2-5: \$30.00

The rates for children are less than the charge by Golden Bell, in accordance with the decision at our last reunion to subsidize the costs in order to allow more families to attend.

To reach Golden Bell, take Highway 24 West out of Colorado Springs to Divide. Turn right at the intersection where State Highway 67 turns south to Cripple Creek, onto North Road/County Road 5. Keep left at the fork, and the road becomes Cedar Mountain Road/County Road 51. Keep left again, and the road becomes County Road 512. Watch for Golden Bell on the left. The lodge is on the south side of the road,

looking out over an awesome view of Pikes Peak.

For those who are interested, there will be a "pre-reunion" Friday noon meal in Colorado Springs at 11:00 a.m. at the Mason Jar Restaurant. We need an approximate number of persons planning to be at the Mason Jar. The Mason Jar is located off Highway 24, about a mile west of I-25. Turn right onto 31st Street, then another right onto Colorado Ave. The Mason Jar is 1 1/2 blocks on the right, at 2925 West Colorado Avenue.

The first official Bowyer Lyness Reunion was in 1951, 60 years ago, so we will be remembering and celebrating the past 60 years.


